DECISION no 40

The Regional Council of Zlínský Region, Department of Environment Protection and Agriculture (hereinafter "Regional Council" only) as the competent local state administrative authority pursuant to § 2 (2), § 29 (1) and § 67 (1) (g) of Act no 129/2000 Coll., on Regions ("Regional Management"), as amended, § 78 (2) (a), (4) (a), § 78 (6) of Act no 185/2001 Coll., on Waste, amending certain other acts, as amended (hereinafter "Waste Act") and in keeping with Act no 500/2004 Coll., Rules of Administration, as amended (hereinafter "Rules of Administration"), following the closed proceeding, hereby issues the below decision by which the legal entity as the party to the proceeding pursuant to § 27 (1) of the Rules of Administration is granted

Approval

In the sense of § 14 (1) of the Waste Act with operation of a facility for collection, repurchase and reuse of waste and with its Rules of Operation (hereinafter "Facility Operation Approval") to

- I. **Concerning operation of a facility for collection, repurchase and reuse of electrical waste of category "O"** situated on plots no 699 and no 6779/3 in the cadastral area of Uherský Brod (hereinafter "Facility"), and further concerning
- II. **Rules of Operation of the facility for collection, repurchase and reuse of electrical waste** issued in September 2017 and updated in January 2019, attached as annex hereto.

The Facility is situated in the southern part of the city of Uherský Brod on the eastern end of Stolařská street and the southern end of Vlčnovská street on plots no 699, and no 6779/3 in the cadastral area of Uherský Brod. The whole premises are fenced and provided with a lockable main entrance gate. The purpose of the Facility is dismantling of discarded EOL electrical appliances and their recycling. The activity is performed in the handling and storage hall on work tables with the help of electrical and manual tools. The dismantled parts are sorted in containers with appropriate identification and forwarded to companies authorised to dispose of the individual categories of waste.

Maximum annual capacity **2400 tons/year**
Maximum instant capacity **20 tons**

The Facility has been provided with facility identification number CZZ00741

The approval is conditioned as follows:

1. The approval is granted for a finite period ending **31 May 2024**
2. The operator is liable to operate the Facility in compliance with its approved Rules of Operation with which all employees of the Facility shall be acquainted in a documented manner.
3. The Facility shall be secured against undesirable impairment, alienation or leaks of waste, above all by protection against unauthorised access.
4. The Facility shall be provided with an information table including appurtenances listed under § 4 (2) (d) of Decree of the Ministry of the Environment no 383/2001 Coll., on Details of Waste Disposal, as amended.
5. Record and reporting of waste collected, repurchased and reused in the Facility shall be maintained in the scope defined by § 39 of the Waste Act and Decree of the Ministry of the Environment no 352/2005 Coll., on Details of Handling Electrical Appliances and Electrical Waste, as amended. Documents on quality of the waste received by the Facility shall be archived for the period of 5 years.
6. In the case of any change of the conditions governing grant of this Approval the change must be notified without delay to the respective administrative office performing public administration in the area of waste management in writing, including any organisational, ownership structure, address or name changes together with the relevant change implementation.
7. This Approval does not substitute for any other decision of measure of state administrative authorities required by special legislation and does not entail any right to grant of a new approval for the Facility operation after elapse of the deadline pursuant to point 1 above herein.
8. The granted Approval shall be changed or cancelled if used over its specified scope or in contradiction to the applicable legislation or in the case of change of any of the conditions governing the approval decision (§ 78 (4) of the Waste Act).
9. The competent administrative authority in the field of waste management hereby reserves the right to prescribe other potential conditions in connection with any amendment or extension of the waste legislation.
10. This decision cancels and fully replaces the decision on approval of operation of a facility for collection, repurchase and reuse of electrical waste and its rules of operation issued by the Regional council on 30 October 2017 under ref. KUZL 65265/2017.

Justification:

The joint-stock company Českomoravská recyklační společnost s.r.o. filed an application with the Regional Council for grant of approval of operation of a facility for collection, repurchase and reuse of electrical waste. The Regional Council as the competent state administrative authority commenced an administrative proceeding in the matter on the date of the application filing.

The facility that is the subject of the application is a facility for collection, repurchase and reuse of electrical waste operated on the basis of the valid permit ref. KUZL 65265/2017 of 30 October 2017 by Českomoravská recyklační společnost s.r.o. for the reason of an update of the rules of operation of the facility Českomoravská recyklační společnost s.r.o. has applied for a new approval of operation of their waste disposal facility.

The Facility is situated in the southern part of the city of Uherský Brod on the eastern end of Stolařská street and the southern end of Vlčnovská street on plots no 699, and no 6779/3 in the cadastral area of Uherský Brod. The whole premises are fenced and provided with a lockable main entrance gate. The activity is performed in the handling and storage hall on work tables with the help of electrical and manual tools. The dismantled parts are sorted in containers with appropriate identification and forwarded to companies authorised to dispose of the individual categories of waste.

The maximum annual capacity of the Facility amounts to 2,400 t/y. Maximum instant capacity is 20 t.

When assessing the application the administrative authority studied the following submitted and updated documents, attached to the administrative document:

- Rules of Operation of the Facility for Collection, Repurchase and Reuse of electrical Waste issued in September 2017 and updated in January 2019,
- Excerpt from the Commercial Register maintained by the Municipal Court in Prague, Section C, File no 169176, of 13 March 2019,
- Standpoint of the Regional Hygienic Station of Zlínský Region to the Rules of Operation, ref. KHSZL 02712/2019, of 5 March 2019,
- Document on payment of the administrative charge,
- Cadastral map, excerpt from the Land Register
- Contract on Property Lease of 1 October 2014,
- Notification on change of landlord with effect as of 22 December 2016, the new owners and landlords being Mr. Dalibor Šmíd and Mr. Jiří Jurák, the lease contract not affected by the ownership change.

One copy of the above mentioned Rules of Operation including annexes will be archived at the Regional Council.

As the submission includes all required appurtenances pursuant to the Waste Act and its executive decrees the competent administrative authority in the field of waste management grants the required approval to the party to the proceeding as described in the text of the decision above.

Appeal Instruction:

The parties to the proceeding can file an appeal against this decision pursuant to § 83 (1) of the Rules of Administration in 15 days from its notification with the Ministry of the Environment of the Czech Republic with specification of the scope in which the decision is contested, and the objected incompliance or incorrectness of the decision or the proceeding preceding this proceeding. The appeal shall be filed via the Regional Council of Zlínský Region, Department of Environment Protection and Agriculture, in 2 counterparts. If the party to the proceeding fails to file the appeal in the required number of counterparts the administrative authority issuing the contested decision shall make the required number of copies at the cost of the party failing to submit them (§ 82 (2) of the Rules of Administration). The filed appeal shall have a postponing effect in compliance with § 85 (1) of the Rules of Administration. An appeal limited to the decision justification only is unacceptable pursuant to § 82 (1) of the Rules of Administration.
